- (i) The above results have been prepared in accordance with Indian Accounting Standards ('Ind AS') notified under section 133 of the Companies Act, 2013, read together with the Companies (Indian Accounting Standards) Rules, 2015 and Companies (Indian Accounting Standards) Rules, 2016.
- (ii) The Unaudited Standalone & Consolidated Financial Results for quarter ended June 30, 2020 have been reviewed by the Audit Committee and approved by the Board of Directors of the Company at its meeting held on September 11, 2020. The same have also been subjected to Limited Review by the Statutory Auditors.
- (iii) The above Unaudited Standalone & Consolidated Financial Results for the quarter ended June 30, 2020 are available on the website of BSE Limited (www.bseindia.com) and on the website of the Company (www.whbrady.in).
- (iv) The figures of quarter ended March 31, 2020 is difference between Year ended March 31, 2020 and Nine month ended December 31, 2019.
- (v) The outbreak of COVID-19 and ensuing mobility restrictions to ensure health and safety of employees and other stakeholders, impacted the Company & Group's trading and manufacturing activities during April, May and June 2020. Trading during the quarter ended June 30, 2020 was for Rs. 212.56 Lakhs which is lower than previous periods (year ended March 31, 2020: Rs. 2050.06 Lakhs; quarter ended March 31, 2020: Rs. 634.60 Lakhs; quarter ended June 30, 2019: Rs. 600.20 Lakhs). Manufacturing during the quarter ended June 30, 2020 was for Rs. 538 Lakhs which is lower than previous periods (year ended March 31, 2020: Rs. 4400.36 Lakhs; quarter ended March 31, 2020: Rs. 787.58 Lakhs; quarter ended June 30, 2019: Rs. 1331.188 Lakhs). During the quarter ended June 30, 2020, the Company and Group have also observed a major decrease in purchase of material and expenses. Further, the Management believes that there may not be significant impact of Covid-19 pandemic on the financial position and performance of the Company & Group, in the long term.
- (vi) Previous Period's Year's figures have been regrouped and reclassified, wherever necessary.
